Online Questionnaire

As soon as you receive your summons, you must fill out your online Juror Questionnaire at www.dekalbjury.com. This advance check-in process will reduce the amount of time for check-in on your day of service. If you are selected to serve on a trial, you must follow any instructions given by the trial judge throughout the duration of the trial. It is important that you check-in now to receive accurate reporting instructions. If you cannot fill it out online, please email info@dekalbjury.com and Jury Administration will assist you with the process.

Juror Health & Safety Precautions

DeKalb County Superior Court has carefully planned for jurors to return to the courthouse, with your health and safety as our top priority. Everyone in the courthouse is required to follow the CDC guidelines and we will continue to update our policies and procedures to ensure compliance with the most current information. Some of the measures we have taken to protect everyone who visits the courthouse:

- ✓ Temperature screening for all jurors, court personnel & visitors
- ✓ Continue to follow the most up-to-date CDC and health department recommendations for mask-wearing inside the courthouse
- ✓ Hand sanitizer stations throughout the courthouse
- ✓ New air filtration systems
- ✓ Jurors prescreened for personal & family health risks
- ✓ Touchless juror check-in process
- ✓ All courtrooms and jury rooms sanitized nightly
- ✓ Restrooms and other high traffic areas sanitized throughout the day

What do I do if I am ill on my service date?

Please contact Jury Administration at info@dekalbjury.com in order to have your jury service rescheduled.

Do not report to jury duty if you are sick.

Do you qualify for a COVID-19 deferral?

- * Are you over age 65?
- * Do you have any serious underlying medical conditions?
- * Are you currently, or have you recently, undergone chemotherapy or another medical treatment causing your immune system to be compromised?
- * Do you live with or care for someone considered to be at increased risk of severe illness from COVID-19? (Anyone who would answer 'yes' to these questions)
